For over thirty years, American Citizens Abroad (ACA) has been defending your rights as a US citizen living abroad. For only \$70 a year you can help ACA with its important work on behalf of Americans living and working overseas. We have successfully worked with Congressman Scott Garrett (R-NJ) to draft legislation eliminating the cap on the FEIE, Congresswoman Carolyn Maloney (D-NY) on preventing overseas Americans from losing their bank accounts as a result of FATCA, and educated nearly 100 Members of Congress on our key issues during Overseas Americans Week (OAW). Over the past year, we have also significantly increased our media exposure, gaining articles in top-tier media outlets such as the New York Times, Bloomberg, Reuters and a major profile piece on FBAR in the Wall Street Journal. This exposure helped increase the pressure on Congress and the IRS to eliminate onerous penalties for Americans overseas. ACA produced documentation outlining the economic hazards of FATCA and the abusive penalties of FBAR which have served as an important resource for journalists, academics, and Members of Congress. ACA was also invited to speak at the "International Tax Withholding Conference," a forum featuring leading tax professionals from across the globe. With your continued support, we can advance even further on each of these issues, helping to defend against unfair attacks against overseas Americans from the IRS, Treasury, and others while proactively making our voice in Washington heard loud and clear.
